# **TERMS & CONDITIONS**

- 1. The bidder has to submit the Technical Brochures of the product in the form of hard copies with required information properly highlighted along with the submission of the Commercial Quotes.
- 2. The quotation has to be submitted in the format given in Annexure-B. The prices of all the components (both hardware and software) should be quoted.
- 3. Manufacturer's Authorisation Form (MAF) has to be submitted, as per the attached format given in Annexure -C, from the OEM whose product is proposed to be supplied.
- 4. The Product shall be under comprehensive onsite warranty for a period of One year from the date of delivery.
- 5. Payment Terms: 75% on the delivery of the hardware and 25% on Installation.
- 6. A penalty of 5% of the Basic Cost of the Hardware Item to be delivered will be charged if the delivery and installation is not done within the maximum period of 25 days from the date of placing of the Purchase Order. The Purchase Order will be cancelled if the delivery is not made by the Vendor within 35 days of placing the order.
- 7. Prices should be all inclusive, but exclusive of GST. GST, if any, will be reimbursed by LIC on production of Invoice for payment to LIC. The GST details of the Vendor and the NEFT details will be provided by the Vendor to the Office before disbursement of the payment.
- 8. The formulation of the Evaluation criteria, the conduct of the evaluation of the responses to the Spot Quotes and the subsequent selection of the successful bidder will be entirely at the discretion of LIC and the decision of LIC will be final and no correspondence in this regard shall be entertained.
- 9. LIC may reject any of the quoted models without assigning any reason and LIC's decision in this matter will be final.
- 10. The Corporation reserves the right to reject any offer in part or full without assigning any reason.
- 11. Any breakdown compliant during the warranty period of One Year should be resolved within 2 days of intimation of breakdown.
- 12. In case of any deficiency in service, action will be taken as per rules.
