Re: Hiring & Maintenance Contract (All in All) of Air Coolers

We need services of Air coolers for our various offices (including our Mofussil Branch Office) for a period of 2.5 months commencing from 15/04/2024 to 28/06/2024. In this connection, we intend to entrust the following job/avail the following services on contractual (All in All) basis and for the purpose, invite tenders in the sealed cover. **Tender date:** 18/03/2024 to 01/04/2024.

Supply of Air coolers with stand on hire-basis (16" PVC Desert Air coolers With Stand).

We need service of 152 (Surat City locations-86, Mofussil Locations - 66) (As per Annexure-A) 16"PVC Desert Air coolers with stand at our various offices and intend to avail the services on hire basis for the contract period. The coolers offered to be supplied to us should be of good quality and in up to date condition and they also have to be kept in working condition throughout the contract period.

General terms of the contract:

- 1. We intend to avail above services for a period of 2.5 months from 15/04/2024 to 28/06/2024 (contract period) which may be extended for One month depending upon setting on of the monsoon season. The service provider will be paid extra charges on prorata basis for the extended period.
- 2. We intend to avail above services in the form of <u>All-in-All</u> contract & as such, No extra charges of whatsoever nature will be paid / reimbursed to the vendor. (Installation of cooler / Replacement of parts etc/conveyance charges / fare for visit to our moffusil branches etc.)
- 3. The service provider (contractor) will have to keep adequate stock of pumps, motors, grills and other spare parts to ensure that the complaint/break-down calls are immediately attended. If such calls are not attended and problem are not solved within 24 hours in Surat city & within 48 hours at moffusil centers, the proportionate service charges for the break-down period will not be paid.

- 4. Service charges/bills will be paid on monthly basis on completion of every month during the contract period and they will not be paid in advance.
- 5. Services of the service provider will be reviewed on weekly basis during the entire contract period and if not found satisfactory, the contract will be terminated forthwith without assigning any reason and without paying any compensation/ charges for the services rendered and the contract will be awarded to another party at the sole discretion of L I C Of India, Surat Division.
- 6. After completion of the contract period, the vendor will have to shift all Air coolers at the place as directed by our office and lift immediately all the hired coolers from our premise. LIC of India is not liable to pay any charges after completion of contract period.
- 7. The contract will be a composite contract for City as well as Mofussil locations and the Service provider accepting the contract will have to render contracted services at the city and designated Mofussil centers as per Annexure-A. The offer given by any vendor in exclusion of either locations (i.e. only for city centers or only for moffusil locations) is liable to be rejected.

Terms and Conditions for Tendering:

- You have to quote your rate in financial Bid. Your rate should be net, inclusive of all charges like delivery charges/ installation and F.O.R. at end location, but Excluding GST.
- Sealed envelope superscribed as "Tender for Hiring & Maintenance Contract (All in All) of Air Coolers at offices under Surat D.O" should reach at the office of the Manager (OS) at address Manager (OS), L.I.C. Of India, Surat Divisional Office, O.S. Dept., Gr.floor, Mugalisara, Surat 395003 on or before 02.04.2024 Up to 12.30 Hrs. Tender will be opened on 02/04/2024 at 16.00 Hrs.
- Please deposit Rs.118/- towards tender fee (non-refundable) in cash or by DD in favor of L.I.C.of India at our office during cash hours before 01.04.2024 (Cash hours Monday to Thursday 10.15 to 4.30 P.M (1.30 to 2.00 Recess) On Friday 10.15 to 4.45 P.M (1.30 to 2.15 Recess) .except (Saturday, Sunday and public holidays) with photocopy of GST certificate & photocopy of pan card.
- 4. You have to enclose copy of receipt of tender fee along with Annexure-A.
- 5. You have to enclose copy of GST Certificate, copy of pan card and original cancelled cheque. (cheque with print of your name)
- 6. The Vendors / Bidders having registration under MSME will be eligible for Exemption from tender fee. This exemption is valid only up to validity period of certificate as per Government regulations.
- 7. The tender without Tender fee will not be considered in any case.



- 8. EMD of Rs.10,000/- to be deposited by Cash or DD in favor of "Life Insurance Corporation of India" payable at surat.
- 9. The Successful bidder will have to Deposit 5% of the total Contract value as Security Deposit within 15 days from the award of the Tender.
- Actual numbers of Air coolers to be taken on hired basis may increase or decrease during contract period according to our need and payment will be made accordingly.
- 11. Contract period of Air Coolers may increase or decrease during contract period according to the situation.
- 12. OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. Bidders are bound to accept the revised quantity or duration.
- 13. If any damage is caused to our premise, furniture or goods while rendering the service, the loss caused will have to indemnify by service provider.
- 14. The LIC of India reserves the right to accept or reject any or all of the offers/ tenders or part thereof without assigning any reason whatsoever.
