- **1.** The bidder has to quote for only the mentioned line item and with the same part code. Otherwise, the quote will be summarily rejected.
- 2. The price quoted should be in Indian Rupees and rounded off to the nearest rupee. The quote should not be in decimals. The quotation should be given for 54 quantity of Apple Smart Keyboard excluding GST.
- **3.** Purchase orders for the additional quantities if any may be placed anytime upto 30.06.2024. Hence the price quoted should be valid up to **30.06.2024** and successful vendor should be able to supply the Apple OEM Smart Keyboard at the quoted rate till 30.06.2024 and quantity upto +-25%.
- **4.** Delivery of Smart Keyboard should be done within maximum 30 calendar days from the date of placing of purchase orders (POs) by LIC. Delivery will be done at LIC Central office, Yogakshema, Nariman Point Mumbai and Zonal offices (8 locations) of LIC of India.
- **5.** The Product shall be under onsite warranty for a period of 1 year from the date of delivery.
- **6.** Payment Terms: 100% on delivery of the Smart Keyboard.
- 7. Maximum Penalty @ 5% will be charged on the Basic Cost of the product if the delivery is not done within the maximum period of 45 days from the date of placing of the Purchase Order that is from the 46th day onwards. The Purchase Order will be cancelled if the delivery is not made by the Vendor within 60 days of placing the order.
- **8.** Prices should be all inclusive but **exclusive** of GST. GST, if any, will be reimbursed by LIC on production of Invoice for payment by the selected vendor. The GST details of the Vendor and the NEFT details will be provided by the Vendor to LIC before disbursement of the payment.
