1. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.

2. Years of Past Experience required: The bidder must have experience for number of years as indicated above in bid document (ending month of March prior to the bid opening) of providing similar type of services to any Central / State Govt Organization / PSU / Public Listed Company. Copies of relevant contracts / orders to be uploaded along with bid in support of having provided services during each of the Financial year.

3. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. 1) **Chartered Accountant Certified Proof of Annual Turnover for FY 2020-21, 2021-22 & 2022-23** in support of condition of minimum average annual turnover mentioned in the bid document which states that "the minimum average annual turnover of the bidder should be ₹ **15 Lakh** .

2) **Copies of Work order/ experience certificate executed in FY 2021-22, 2022-23 & 2023-24** in support of condition specified in Bid Document for Years of Past Experience which states as " The bidder must have experience for number of years as indicated above in bid data sheet (ending month of March prior to the bid opening) of providing similar type of services to any Central / State Govt Organization / PSU / Public Listed Company"

3) **Copies of Work orders/ experience certificate executed in FY2021-22, 2022-23 & 2023-24** in support of condition specified in Bid Condition for Past Experience of Similar Services which states as "The Bidder must have successfully executed / completed at least one single order of **80 %** of the Estimated Bid Value i.e. 13.60 lakhs or 2 orders each of **50 %** of the Estimated Bid Value i.e. 8.50 lakhs or 3 orders each of **40 %** of the Estimated Bid Value i.e. 6.80 lakhs for similar service(s) in last three years to any Central / State Govt Organization / PSU / Public Listed Company.

4) Signed Copy of **Buyer Organization Specific Integrity Pact**, specimen uploaded in the Bid Specific terms and conditions, specimen uploaded in point 2 of Buyer added bid specific terms and conditions.

5) **Satisfactory Performance Certificate from minimum 2 Clients** (Different Organizations) issued for the works executed within last **5 Financial Years including the current Financial Year**.

6) A **Declaration** shall be uploaded by the vendor "**the Bidder should not be under liquidation, court receivership or similar proceedings, should not be bankrupt and is not blacklisted** by any Central / State Govt Organization / PSU / Public Listed Company". The declaration submitted shall be signed and dated **after Bid publish date**.

In Addition to the Service Level Agreement of GeM, Contract shall also be governed by the following terms and conditions.

1) Please note that D.G. Set of reputed make viz. **Cummins India / Kirloskar Green /Greaves/Mahindra & Mahindra Ltd./ Ashok Leyland/Tata Motors/Eicher TMTL** only be accepted. DG Set shall be suitable to generate 1/3 phase 415 volts, 50 Hz at 1500 rpm complete in all respects with acoustic enclosure conforming to the norms of pollution control board. The approval of make of Engine, Alternator & Enclosure must be obtained well before procurement. If at any stage it is found that D G set provided is not of approved make, LIC reserves the right to order the contractor to remove the DG set & provide new DG set as per approved makes.

2) Extra Running of DG Set beyond the package limit of **30/hrs per month** will be paid on pro rata basis as per Ge M SLA for this service.

3) Operator Waiting Charges for the duty beyond the duty hours shall be paid as ₹ 100/ hour, further No Extra Operator charges for Saturdays during the duty hours, shall be paid.

4) The successful tenderer has to submit copies of invoices after procurement of D.G.set. The name, address & phone no. of service centre shall also be mentioned.

5) The following tests shall be performed at manufacture's outlet prior to packing & dispatch to site :-

- a. Load test at full load 50% load, 75% and 110% overload.
- b. Fuel consumption at full load, 75% load, 50% load and 25% load.
- c. Other routine test as per IS / BS on alternator, exciter and AVR.
- d. Noise level measurement.

Copies of test certificates shall be submitted to LIC of India.

6) The arrangements for providing accessories like new cables, new change-over switches, and fresh earth stations will be made by the contractor at their own cost. If the mentioned items not provided by the vendor, Corporation shall arrange at the risk & cost of the vendor and same shall be recovered from the monthly hiring charges of the vendor.

7) Electric Duty, if any payable to the State Govt. depending on running hours of the DG Set shall be borne

by the contractor. Installation of Energy meter with its calibration and registration with the Statutory Authority shall be done by the contractor at their own cost.

8) The Contract Shall remain in force initially for a period of three years from the date of installation and satisfactory commissioning of the DG Set at Site which may be renewed for further period of two years at the accepted rates / charges and keeping other terms & conditions unchanged, depending upon the satisfactory services rendered by the generator supplier and requirement of the office.

9) Price Adjustment for the cost of running of DG Set due to variation in price of Diesel shall be done on basis of fuel consumption of diesel for operation of DG in a given period as per below mentioned calculation

Successful Vendor has to claim variations, if any with their monthly bills.

10) Successful Vendor has to obtain Insurance Policies to cover Third Party Liability, Fire and Workmen Compensation Insurance of suitable amount for each policy which shall remain in force till the contract period and extension if granted. Payment shall be withheld if the Insurance Policy Lapse and penalty @ ₹ 200 per day for such lapse period shall be recovered from the bill raised by the contractor.

If the Policies are not renewed within 30 days of expiry, corporation may get the insurance policies renewed and Premium Amounts along with the penalty of ₹ 25000 shall be recovered from the vendor.

The contractor shall be wholly responsible for any mishap during such lapse period and damage recoveries if any shall be made from the payment to the contractor.

11) In the event of breakdown of DG Set due to unavailability of fuel or whatsoever reason on the part of vendor a penalty of 5% of monthly rent per hour shall be levied on the contractor. This penal clause overrides the penalty clause mentioned in GEM SLA.

12) Unauthorized supply of power to other agencies / firms from the DG Set installed at our premises if any are found, action will be taken against the vendor as deemed fit by the competent authority.

13) The Contract is subject to termination at any time if the services are not found satisfactory by LIC or for any other reason whatsoever by serving 30 days notice in writing by LIC and 90 days notice by the agency .

14) The contractor will have to remove the DG Set from the LIC Premises within 07 (Seven) days from the date of termination or closure of the contract at their cost, else demurrage charges @ ₹ 1000/day will be levied by the LIC of India, on the contractor.

15) A Log Book shall be maintained for recording daily running of DG Set which should be signed by the DG Set operator and verified by the authorized official of LIC of India.

16) LIC of India shall not be responsible for any injury partial or permanent or death of any worker at site due to accident or by personal negligence of the staff of the contractor. LIC of India will remain indemnified by the contractor on this account .

17) Contractor shall be responsible for payment of wages / salaries and allowances to his personnel that m

ight become applicable under any government order. LIC of India shall have no liability whatsoever in any manner.

18) In terms of provisions of Section 33 (3) of the Insurance Act, 1938 as amended by the Insurance Laws (Amendments) ordinance, 2014. Insurance Regulatory Authority of India (IRDAI) is authorized to verify all such books of account, register, other documents and data base in the custody of the contractor in respect of service outsourced by the LIC of India. It shall be the duty of the contractor to provide such documents / statements / information / as may be required by IRDAI within such time as may be specified by the IRDAI.

3. **Generic**

4. **Certificates**

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. Any clause(s) incorporated by the Buyer regarding following shall be treated as null and void and would not be considered as part of bid:-

Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
