- 2. The last date/time for submission of the tender documents is 12.07.2024 up to 3.00 pm
- 3. The premises where the LED signage Boards are to be installed can be inspected from 24.06.2024 to 11.07.2024 from 11.00 am to 4.00 pm. Interested bidders may contact the following officials for the inspection of the premises and for any enquiry between 10.00 am to 5.30 pm on any working day.

- 4. The Tender applications /documents received after the last date and time shall be rejected. In case the last date of issue/receipt/opening of tender documents is declared a holiday / happens to be a holiday, the tender shall be issued / received and opened on the next working day at the same timings.
- 5. The bidding shall be two bid system. The technical bids shall be opened on the same day i.e. 12.07.2024 at 3.30 pm. The details of opening of the financial bids of the eligible bidders / Vendors shall be intimated separately.
- 6. The authorized signatories of the bidders / Vendors shall sign on each page of the tender documents in proof of agreeing to the terms and conditions mentioned therein. There shall be no footnote or remarks by the Vendors, other than the details that are asked for in the tender and any bids that contain such footnotes /remarks are liable to be rejected.
- 7. The tender documents shall be placed in two separate covers, one containing the Technical Bid along with the DD/Bankers' Cheque for the EMD Amount, while the other cover shall contain the Financial Bid. Both the covers shall be placed in a separate bigger cover and sealed and superscribed as "Application for Installation of LED Signage Board on the Terrace of Three LIC Buildings" and shall be addressed and sent / handed over to
