- 1. Experience Criteria: In respect of the filter applied for experience criteria, the Bidder or its OEM {themselves or through reseller(s)} should have regularly, manufactured and supplied same or similar Category Products to any Central / State Govt Organization / PSU for number of Financial years as indicated above in the bid document before the bid opening date. Copies of relevant contracts to be submitted along with bid in support of having supplied some quantity during each of the Financial year. In case of bunch bids, the category of primary product having highest value should meet this criterion.
- 2. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 25% (selected by Buyer) percentage of total quantity. - 3. #### 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

### 2. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

- 1) Eligible makes for Participation are **Exide/ Amaron Quanta only.** Rest makes shall not be considered for technical evaluation.
- 2) Rates are to be quoted inclusive of Buy Back i.e For Example if Rate of New Battery is X and Rate of B uy Back Battery of same capacity is Y, then the Quoted Rate shall be (X-Y)
- 3) For **Technical evaluation** bidders are requested to submit the following documents:
- a) Copies of work order/experience certificate executed in FY 2022-23 & 2023-24 in support of condition specified in Bid document for years of past experience i.e. 2 years which states as " the bidder should have regularly, manufactured/supplied same or similar Category Products to any central / state Govt organization/PSU/ Pu blic Listed Company for number of financial years as indicated above in the bid document before the bid opening da te. Copies of relevant contracts to be submitted along with bid in support of having supplied some quantity during e ach of the Financial year.
- b) Copies of work order/experience certificate executed in FY 2022-23 & 2023-24 in support of condition of past experience which states that" the bidder should have supplied same or similar Category Products for 50% (58 batteries) of bid quantity in at least one of the last two financial years before the bid opening date to any centra I / state Govt organization/PSU/ Public Listed Company . Copies of relevant contracts ( proving supply of cumulative order quantity in any one financial year ) to be submitted along with bid in support of quantity supplied in the relevant financial year."
- c) Valid OEM Authorization Certificate of Financial Year 2024-25.
- d) A **Declaration** shall be uploaded by the vendor "the Bidder should not be under liquidation, court receivership or similar proceedings, should not be bankrupt and is not blacklisted by any Central / State Govt Organization / PSU / Public Listed Company". **The declaration submitted shall be signed and dated after Bid publish date**.
- 4) Unloading charges are to be paid by the successful bidder. Also the successful vendor ensures the Supply / Inst

allation / Testing / Commission of batteries at the respective locations at his own cost.

**5) Liquidated damages**: If the seller / Service provider fails to deliver any or all of the Goods/ Services within the Original/re-fixed deliver period(s) specified in the contract, the buyer will be entitled to deduct / re-cover the liquida ted damages for the delay, unless covered under Force Majeure conditions aforesaid **@ 0.5 % of the contract** value of delayed quantity per weak or part of the weak of delayed period as pre-estimated damages not exceeding 10% of the contract value of delayed quantity without any controversy/dispute of any sort whatsoever.

### 3. Scope of Supply

### Disclaimer/अस्वीकरण

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

- 1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
- 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for attached categories, trials are allowed as per approved procurement policy of the buyer nodal Ministries)
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

In terms of GeM GTC clause 26 regarding Restrictions on procurement from a bidder of a country which shares a land border with India, any bidder from a country which shares a land border with India will be eligible to bid in this tender only if the bidder is registered with the Competent Authority.
