#### 3. Average Annual Financial Turn Over:

The Applicant should have Average Annual Financial Turn Over as mentioned in the table above for similar nature of works during <u>last Three years</u> ending 31<sup>st</sup> March 2024. - (a)Qualifying value of work completed during last 7 years (up to 31st July 2024)
- (a)7 years shall be considered from **last day of month previous** to the one in which applications are invited.
- **II)** For arriving at current cost of similar works, value of qualifying work executed shall be brought to current costing level by enhancing the actual value of work at a simple rate of 7% per annum calculated from the date of completion to the last date of submission of application of empanelment.
- III) "Similar nature" means the characteristics of the completed works should be similar to that of the trade mentioned in the table above.

# Hence, similar nature of work means Specialized Civil works like Structural Repairs and Restoration works & Water proofing works at Buildings, etc.

- IV) The applicants need to submit completion certificate for all qualifying works, containing the details such as Date of Commencement & Completion, details of similar nature of works, Final Completion Cost duly certified by Authorized official in case of Govt / Semi Govt or Public Sector Undertaking.

### 5 Disqualification:

Even if an applicant meets the Qualification Criteria, he shall be subject to disqualification if he or anyone of the constituent partner/Director is found to have:

- i) Made misleading or false representations in the forms, statements, affidavits and attachments submitted in proof of the qualification requirements **and** / **or**
- ii) Records of poor performance during the last five years, as on the date of NIT, such as abandoning the work, rescission of the contract for reason which are



attributable to non performance of the contractor, inordinate delays in completion, consistent history of litigation resulting in awards against the contractor or any of the constituents, or financial failure due to bankruptcy and so on and / or.

- iii) On account of currency of debarment by any Government Agency
- IV) The agency is not having GST registration, PAN NO. & DSC.
- (a) Joint Ventures applicants will not be considered.
- 7. Application for Empanelment, tenders and all communications till award of work shall be signed only by Proprietor of Proprietorship firm/Authorised partner in case of partnership Firm/Authorised person of company, Public, Limited firm etc. For these purposed, power of attorney shall not be considered. Power of Attorney may be considered for specific purpose after award of work such as for site instructions/communications, signing bills and other related matters for billings and payments etc.,
- 8.Performance Report for qualifying works shall be called from Client as per Proforma-Annexure I.

Registration of the Agencies: Agencies desires to apply for empanelment through online
using Electronic Tendering System (ETS) are required to get registered on the eTender
Portal (website) <a href="http://www.tenderwizard.com/LIC">http://www.tenderwizard.com/LIC</a>

After successful Registration on above mentioned portal **Agency will** get a User ID and Password to access the website.

- Viewing of Online Tenders: The contractors/bidders can view tenders floated on online
  Electronic Tendering System (ETS) hereinafter referred as "e-Tendering System" through
  portal (website) at <a href="http://www.tenderwizard.com/LIC">http://www.tenderwizard.com/LIC</a>. They can view the details like Tender
  Notice, Terms and Conditions, drawing (if any) and any other information. To download
  through they need to login on to the above portal and can download the tender documents
  of an e-Tender.
  - Obtaining a Digital Certificate and its Usage: On e-Tendering System the bids should be Encrypted and Signed electronically with a Digital Signature Certificate (DSC) to establish the identity of the bidder on online Portal. The Digital Signature Certificate (DSC) has two keys i.e. Public Key and Private Key. The Public Key is used to Encrypt (code) the data and Private Key is used to decrypt (decode) the data. The Encryption means conversion of normal text into coded language whereas decryption means conversion of coded language into normal text. These Digital Signature Certificates (DSCs) are issued by an approved Certifying Authority, by the Controller of Certifying Authorities (CCA India), Government of India.
  - The contractors may obtain Class III digital certificate from any Certifying Authority or Sub-certifying Authority authorized by the Controller of Certifying Authorities on the portal <a href="http://cca.gov.in">http://cca.gov.in</a>. or may obtain information and application format and documents required for issue of digital certificate from our Service Provider for Electronic Tendering System (ETS):

- The Filled in Enrolment form has to be submitted using the Digital Signature Certificate (DSC), which is used to Encrypt (codified) the data and sign the Hash (Impression of your data) during the stage of Bid Preparation and Hash submission. In case, during the process of a particular e-tender, the user loses his Digital Certificate (i.e. due to virus attack, hardware problem, operating system problem), he may not be able to submit the bid online. Hence, the users are advised to keep their Digital Signature Certificates in safe custody.
- The same procedure holds true for the authorized users in a private/Public limited company. In this case, the authorization certificate will have to be signed by the directors of the company.
- Agencies participating in empanelment shall check his/her validity of Digital Signature
   Certificate before applying in the e-Tendering Portal (website) through
   http://www.tenderwizard.com/LIC.

#### • Submission of Enrolment Form Fee:

Agencies have to deposit Non-refundable Enrolment form fee in the form as stated in of DD in a sealed envelope on and before of required amount as mentioned in the respective e-Tender in the form of "CROSSED DEMAND DRAFT" of any of the Nationalized Banks drawn in the favour of the "Life Insurance Corporation of India" payable at "Mumbai" only, and not in the favour of any other Authority or Location .

- The Enrolment fee is Non-refundable.
- A scanned copy of DD against Enrolment Fee should be uploaded mandatory while filling stage (as per the Key Dates) and original D.D. payment details should be submitted to Chief Engineer, LIFE INSURANCE CORPORATION OF INDIA, Engineering Department, 1<sup>st</sup> floor, West Wing, Western Zonal Office, "Yogakshema", Jeevan Bima Marg, Mumbai 400 021 in the separate sealed envelope on or before the due date mentioned in Key Dates, otherwise filled in enrolment form will not be opened.

## • Submission of Enrolment form through online :

The Agencies are required to prepare their Filled in Enrolment form in e-Tendering Portal as mentioned above. During filling / preparation the agencies have to send their Public Key of DSC hence they are advised to procure DSCs at earliest to participate in the e-Tender portal. They are required to upload the scan copies of Demand Draft / Proof of NEFT or RTGS payment details for enrolment form Fees. Also agencies are required

scan and upload any other documents related to their credentials and submit wherever asked online. The bidders have to prepare their commercial bid online during in this stage only and seal (Encrypt) and digital sign the online bid with their Digital Signature Certificates. The Agencies should take note of any corrigendum being issued on the web portal on a regular basis. They should view and note down or take a printout the Bid Hash submitted and ensure that it matches during "Re-Encryption of Bids" stage. The Agencies will not be able to change their technical details and offer (rates) after expiry of due date and time on online portal.

- Generation of Super Hash: After the time of submission of Bid Seal (Hash) by the Agencies has lapsed, the bid round will be closed and a "Digitally signed tender Super-Hash" will be generated by concerned LIC Department official. This is equivalent to sealing the tender box.
- Re-Encryption of Bids: Once the Generation of Super Hash stage is completed the Agencies have to decrypt their bids as they are in encrypted mode by their DSC and reencrypt with Department user's Public Key which will be included in the e-Tender. During this process they need use their DSC for decryption of Bids and signing of Bid Hash once again for security. The electronic bids of only those Contractors/bidders who have submitted their bid seals (hashes) within the stipulated time, as per the tender time schedule (Key Dates), will be accepted by the system. A Contractor who does not submit his bid seal (hash) within the stipulated time will not be allowed to submit his bid (Re-Encryption). This stage could be considered as transfer of control to LIC Department user.
- Opening of Submitted Enrolment forms by both Physical & Online mode:
  - (a) Filled in Enrolment forms shall be opened on key dates.
