# BIDDING PROCESS



• This is an e-Tender – Bids must be submitted "ONLINE"

Original Bank Guarantee of EMD, MSME/NSIC Certificate and Precontract Integrity Pact should be submitted separately in a sealed envelope within 3 days of opening of Eligibility Bid.

• The evaluation for **2FA Solution** will occur in three stages:

## Stage 1 - Eligibility Criteria Evaluation

- Bidders must meet all eligibility criteria listed in Annexure-II (Minimum Eligibility Criteria and Bidder Details).
- Documents must demonstrate financial capacity, technical skills, and relevant experience.

# **BIDDING PROCESS**



## Stage 2 - Technical Bid Evaluation

- Only bidders fulfilling eligibility criteria will be eligible for technical evaluation based on Annexure-X (Functional and Technical Requirements).
- Includes Proof of Concept (POC) demonstration and technical presentations, if requested.

## Stage 3 – Indicative Commercial Bid Evaluation

- Indicative Commercial Bid of bidders qualifying in Eligibility and Technical evaluation will be opened
- Selection of L1 Bidder will be done through Online Reverse Auction



- Bidder should be a registered entity in India or a company/ statutory body owned by Central/State Govt
- The bidder must have a valid GST registration.
- The bidder must have a valid PAN number.
- The bidder must have a valid ISO 9001 certification for information security management.
- The bidder must be in business of providing Two factor Fingerprint Biometric Solution for a minimum period of 3 years as on the date of this RFP.



- Successfully implemented proposed 2FA fingerprint biometric solutions in at least 3 BFSI/PSU/Government entities, supporting a minimum of 5,000 users each in the last five years prior to the date of RFP. Deployed solution should have capability to support up-to 80000 biometric fingerprint devices and 150 concurrent users.
- Must provide technically qualified personnel for integration/ implementation of proposed 2FA solution.
- Back-to-back agreement with the OEM for maintenance and upgrades(including all software and hardware).
- Bidder (including its OEM, if any) should be Class-I local supplier as defined in Public Procurement (Preference to Make in India) Revised Order (English) dated 19/07/2024. This condition is for bidders/OEM who are bidding under Public Procurement (Preference) to Make in India



- The bidder should have registered standalone revenue of atleast Rs.20 crores each year in the last three accounting years preceding the date of release of the RFP
- The bidder has registered net profit in the last three accounting years preceding the date of release of RFP
- Bidder should have positive net worth in each of the last 3 FY (2021-22, 2022-23 & 2023-24)



- Bidder should not be blacklisted on the date of bid submission by any Government / Government of India / State/UT Government/ PSUs / Banks / Any other Institution in India or abroad
- Bidder should not have any litigation against LIC or any organization which may materially impact the bidders' responsibility to implement the scope of this RFP
- Power of Attorney: The bidder must submit a duly executed Power of Attorney.

# SCOPE OF WORK



- Manage project planning, solution implementation, integration testing, roll-out, and provide ongoing warranty and support.
- End-to-end implementation of biometric authentication solution, including related hardware, software, installation, commissioning, and testing.
- The proposed solution should be a single interface, applet-less, browser-independent. The Client machines will be accessing the proposed solution through Mozilla Firefox, Google, Chrome, Microsoft Edge etc. where the finger print devices are connected.
- The proposed solution should be compatible with the existing Cogent CSD 200/200i, Precision PB510, and Mantra MFS100 devices and any other new devices procured by LIC.

# SCOPE OF WORK



- Migration of existing data such as employee profiles and fingerprint data, ensuring de-duplication, and hardware sizing to meet current and future needs.
- Customization of the application software and its integration with the LIC's core insurance application and any other web application.
- Maintenance and onsite support for each software and hardware components procured through this RFP.

## REQUIREMENT



- 2FA Solution should be able to integrate with key applications such as eFEAP, Concurrencia, eDarpan, EDMS, PAMS, Customer 360 etc.
- The solution should supports existing biometric fingerprint scanners - Gemalto CSD200/200i, Mantra MFS100, and Precision PB510 and any other devices procured by LIC.
