Please quote your rates on our tender description Performa, which should be signed under your official seal. The tender with cuttings or fluids will not be accepted.

If the supply is not received within stipulated time, the order will be cancelled and action will be taken as per rules. You are required to deposit Earnest Money Deposit {Refundable} of Rs.6000/-{Refundable} & Tender fee of Rs. 118/- {non refundable} separately by Demand Draft fvg. LIC of India payable at Karnal along with the tender. EMD of the tenderer/s not getting the order will be refunded without any interest after finalization of the tender. If the quantum of order exceeds to Rs.
