1. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price. The buyers are advised to refer to the OM No.1 4 2021 PPD dated 18.05.2023 for compliance of Concurrent application of Public

Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if the credentials of the service provider are validated online in GeM profile as well as validated and approved by the Buyer after evaluation of submitted documents.

- 2. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price.
- 3. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

1. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

- 1. Financial Bids of only those vendors will be considered for evaluation who will submit the declaration on their letter head that
- a. They have gone through all the terms and conditions and are accepted to them.
- b. They will pull policy dockets from the racks, segregate the documents from the dockets, th en rearrange the dockets in the shelves as per instructions of LIC
- c. Put the segregated papers & Dockets in separate bags as per scope of work
- d. All necessary materials viz., ladders, gloves, masks, cleaning liquid, bags etc will be provid ed by the vendor without any extra cost.

SCOPE OF WORK AND GENERAL TERMS & CONDITIONS FOR RECORD PULLING & S EGREGATION OF DOCUMENTS FROM THE POLICY DOCKETS

- 1. This Bid is floated for pulling out of approximately 1.5 Lakh Policy Dockets from the Racks placed & then Separation of Documents from the Policy Dockets at our RMF C entre addressed at Mahajan Rice & General Mills Vallah Sabzi Mandi, next to Mahajan Kanda, Mehta Road Amritsar.
- 2. Vendor is required to take out the policy records from racks as per the list given by us. Excel format list will be provided both in soft file & hard copy which contains details of policy no, branch no, batch no. of old policy records.
- 3. Rearranging of balance dockets as per our requirement in racks & revised numbering of the shelves and racks. Creation of vacant racks and their rearrangement as per our instructions.
- 4. Segregation of docket covers & the papers inside dockets will be done by vendor after thorough verification by L.I.C. official.
- 5. Papers inside docket shall be packed inside the big bags, Bags will be provided by the vendor only.
- 6. Empty Dockets shall be packed in bags in bundle of 1000 dockets. Bags will be provided by the vendor only

Detailed Job Description for Taking out Dockets from policy racks

- 7. Taking out the lapsed policy records from racks as per the list provided by LIC office.
- 8. After verification by LIC officials, the docket cover and the papers inside to be segregated & kept separa tely by vendor.

- 9. Dockets Covers in the bundles of 1000 will packed in Bags
- 10. Segregated papers shall be packed separately in the Bags.
- 11. Rearranging of records (dockets) backwards in the space generated in racks
- 12. Renumbering of shelf & racks, rearrangement of vacant racks as per instructions of LIC.
- 13. The successful bidder should produce the names and Id-proofs of the persons who will be engaged for these services for issue of temporary entry pass which should be produced on demand.
- 14. All labour charges involved in the above contract job for various activities have to be borne by the bid der only. Successful bidder should comply all statutory labour laws and regulations.
- 15. The bidder should engage such persons who are adequately literate to read 8 or 9 digit policy nos and physically fit so that they can take out records and renumber the racks after rearrangement. Vendor should deploy adequate number of persons to complete the job.
- 16. The bidder has to arrange for necessary materials viz., ladders, gloves, masks, cleaning liquid, bags et c for the work and persons engaged in the job
- 17. Corporation reserves the right to increase or decrease the number of dockets at any time during the c urrency of the contract. Successful Bidder is bound to accept the orders accordingly. Payment then shall b e made on the pro rata basis.
- 18. Corporation reserves the right to terminate / cancel the whole or part of the agreement at their sole discretion.
- 19. Contractor is to fully indemnify the LIC of India against any type of loss/accident caused due to neglige nce of the contractor and he should take all the precaution for smooth execution of work.
- 20. In terms of provisions of Section 33 (3) of the Insurance Act, 1938 as amended by the Insurance Laws (Amendments) ordinance, 2014. Insurance Regulatory Authority of India (IRDAI) is authorized to verify all s uch books of account, register, other documents and data base in the custody of the contractor in respect of service outsourced by the LIC of India. It shall be the duty of the contractor to provide such documents / statements / information / as may be required by IRDAI within such time as may be specified by the IRDAI.

2. Forms of EMD and PBG

Successful Bidder can submit the Performance Security in the form of Account Payee Demand Draft also (besides PBG which is allowed as per GeM GTC). DD should be made in favour of

LIC OF INDIA payable at AMRITSAR

. After award of contract, Successful Bidder can upload scanned copy of the DD in place of PBG and has to ensure delivery of hard copy to the original DD to the Buyer within 15 days of award of contract.

Disclaimer/अस्वीकरण

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

- 1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.

- 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for <u>attached categories</u>, trials are allowed as per approved procurement policy of the buyer nodal Ministries)
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
- 15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

This Bid is governed by the <u>General Terms and Conditions/सामान्य नियम और शर्तें</u>, conditions stipulated in Bid and <u>Service Level Agreement</u> specific to this Service as provided in the Marketplace. However in case if any condition specified in General Terms and Conditions/सामान्य नियम और शर्तें is contradicted by the conditions stipulated in Service Level Agreement, then it will over ride the conditions in the General Terms and Conditions.

In terms of GeM GTC clause 26 regarding Restrictions on procurement from a bidder of a country which shares a land border with India, any bidder from a country which shares a land border with India will be eligible to bid in this tender only if the bidder is registered with the Competent Authority.
