 - For arriving at current cost of similar works, value of qualifying work executed shall be brought
 to current costing level by enhancing the actual value of work at a simple rate of 7% per annum

 - Similar Nature* means the characteristics of the completed works should be similar to that of
 the proposed building in terms of physical parameters, like Heritage Building external
 structural repair & painting, method/technology and/or other characteristics described and

- ii) Records of poor performance during last five years, as on the date of NIT, such as abandoning the work, rescission of the contract for reason which are attributable to non performance of the contractor, inordinate delays in completion, consistent history of litigation resulting in awards against the contractor or any of the constituents, of financial failure due to bankruptcy and so on.
