- 1. The firm/company should have at least three years standing.
- 2. The firm/company must have a PAN and GST Registration. Please give the details of PAN/TIN/GST Registration details on enclosed format and enclose all photocopies with the Application form.
- 3. The duration of the empanelment will be for a period of 2 years from the date of empanelment that may be discontinued at any time without giving any reason by the Corporation.
- 4. The period of empanelment may be extended for further one year with same terms & conditions after taking the approval of the competent authority if the services of the vendor found satisfactory.
- 5. The eligibility conditions and application form (Annexure A) can be obtained from Manager (Sales), LIC of India, Divisional Office, Meerut (U.P.) or can be downloaded from our website www.licindia.in (link tenders).
- 6. Completed application form and other documents should be submitted in a sealed envelope mentioning "Registration for empanelment to purchase Competition Prizes/Gift items" to Manager (Sales), Sales Department, Divisional Office, Prabhat Nagar, Meerut. Last date of submission the application form duly completed is 24.01.2025 up to 5.30 p.m. Application received after last date and time, will not be considered and therefore deemed to be rejected.
- 7. Application/Processing fee of Rs 100.00 (nonrefundable)+ GST @ 18% should be remitted by way of depositing CASH at Cash counter of Divisional Office during the office hours in any working day. OR the application fee Rs 118/- may be submitted by way of Demand Draft drawn in favor of LIC of India payable at Meerut with Application form.
- 8. Each page of application form with all enclosures should be signed by the authorized person and his /her name and status should be indicated below his/her signature along with official seal of the firm.
- 9. Incomplete and/or conditional applications will be rejected.
- 10. Mere submission of application for empanelment doesn't confer the right of empanelment. Life Insurance Corporation of India reserves its right to reject, accept or cancel the process of empanelment without assigning any reason thereof for which Life Insurance Corporation of India shall neither be liable nor obligatory to inform the applicant the grounds of any such action.
