- 1. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.
- 2. 1) This bid is floated for procurement of Renewal Premium Receipts used by Life Insurance Corporation of Ind

ia, with size of **15.24 cm x 25.4 cm (i.e. 6" x 10" x 1)**, Receipt is having a main part and a counterpart wit h a perforation at **19cm** from the top for the counterpart of the receipt. Theses Renewal Premium Receipts ar e computer continuous stationery printed on paper of having thickness of paper a s minimum 80 GSM with single color printing.

- 2) Quoted rates shall be valid for a period of 1 year, and tendered quantity i.e. (20 Lakh RPR'S) s hall not be procured under single purchase order, multiple purchase orders shall be issued durin g the currency of contract as per the requirement of office with a provision of 25 % increase or d ecrease in the tendered quantity.
- 3) Sample image of the desired product is uploaded at **Page No.3** of the bid document for reference. Also **Supplied receipts shall have numbering over it at the main part and counterpart along with Name of vendor, quantity printed and month/year of printing.**
- 4) After award of contract, successful bidder shall submit the soft copy of Receipt for Proof Reading within **07 Days** after the art work provided to the bidder and delivery period of one month shall start once proof is approved by the office.
- 5) Successful bidder is required to make entire supply ordered by LIC of India Srinagar Division within stipulat ed time of one month or as mentioned in the order and in case the firm fails to supply the goods/items within the time limit/or not as per the required specifications penalty @ as given below will be calculated an d dedu cted from the invoice without any intimation.

- 6) In terms of provisions of Section 33 (3) of the Insurance Act, 1938 as amended by the Insurance Laws (Am endments) ordinance, 2014. Insurance Regulatory Authority of India (IRDAI) is authorized to verify all such bo oks of account, register, other documents and data base in the custody of the contractor in respect of service outsourced by the LIC of India. It shall be the duty of the contractor to provide such documents / statements / information / as may be required by IRDAI within such time as may be specified by the IRDAI.
- 7) For **Technical Evaluation** Bidders are requested to submit following documents:

- c) Copies of Work orders executed in **FY 2021-22, 2022-23 & 2023-24** in support of condition specified in Bid Condition for Past Experience of Similar Services which states as "The bidder must have successfully exe cuted/completed similar Services over the last three years i.e. Three similar completed services costing not le ss than the amount equal to 40% (forty per cent) of the estimated cost(i.e. **2.80 Lakhs**); or Two similar completed services costing not less than the amount equal to 50% of the estimated cost(i.e. **3.5 Lakhs**); or One similar completed service costing not less than the amount equal to 80% (eighty per cent) of the estimated cost(i.e. **5.60 Lakhs**)."

8) Any dispute arising out of the Contract/Agreement shall come under the jurisdiction of the Ho norable Courts in Jammu only.

2. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

- 1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.

- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for <u>attached categories</u>, trials are allowed as per approved procurement policy of the buyer nodal Ministries)
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
- 15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers / Service Providers are mandated to ensure compliance with all the applicable laws / acts / rules including but not limited to all Labour Laws such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972 etc. Any non-compliance will be treated as breach of contract and Buyer may take suitable actions as per GeM Contract.

This Bid is governed by the <u>General Terms and Conditions/सामान्य नियम और शर्तें</u>, conditions stipulated in Bid and <u>Service Level Agreement</u> specific to this Service as provided in the Marketplace.
