The Advertising agencies desirous to be empanelled with us and fulfilling the eligibility conditions may apply as per proforma for selection of Ad agencies.

The application proforma as per Annexure-1 along with the required documents as enclosures are to be submitted in sealed Cover superscripted with specific item at the following address, so as to reach us before 10.03.2025 at 12 Noon.

#### **CONDITIONS FOR EMPANELMENT:**

- 1) The Agency should not be on the panel of any other Life Insurance Company.
- 2) The Agency should be financially sound, having average gross income 5 crores & above.
- 3) The Agency should be registered and should provide Registration as well as GST Number.
- 4) The Agency should not have any complaints or court cases pending against them.
- 5) It should be accredited by Indian Newspaper society.
- 6) It should have a full-fledged office at LIC's Zonal Headquarters, Kolkata.
- 7) The agency should have at least 5 years standing.
- 8) The agency should have at least five clients other than LIC.
- 9) The Agency should be able to translate in the specified regional languages.
- 10) The Agency should be able to carry out public relations & publicity, creative artwork, media artwork, media buying for press, TV, radios, digital advertising, events etc.
- 11) The Agency should not be in LIC's Central Office panel.

The Cover should be superscribed as "Application for Empanelment of Advertising Agencies (other than OOH)".

#### Note:

- 1. Advertising Agencies who are in Zonal Office existing panel should also apply for fresh empanelment.
- 2. Advertising Agencies who have been blacklisted/removed earlier should not apply. If applied their applications will not be considered.
- 3. Self attested Photocopy of the documents should be submitted as proof with application forms. However, originals will have to be shown for verification at a later date.
- 4. Advertising Agency which fulfill the criteria mentioned above will be short listed for presentation before the Corporate Communications Advisory Committee. The presentation will cover points as mentioned in the prescribed application form.
- 5. Application received after due date & time and applications which are incomplete are liable to be rejected without any further reference.
- 6. LIC of India, Eastern Zone reserves the right to reject any or all applications without assigning any reason thereof.
