EMPANELMENT OF AGENCIES FOR OUTDOOR ADVERTISING AND BRANDING OF BUILDINGS FOR E. Zone.

Applications are invited from the established Vendors/Firms/Companies (hereafter called as "Vendors" only) who are engaged with execution of OOH (Hoarding/Neons/LEDs etc) moving displays, indoor displays and maintenance activities for empanelment of vendors OOH publicity works at Eastern Zonal Office level under Eastern Zonal jurisdiction (West Bengal and entire North East). The Advertising agencies and vendors desirous to be empanelled with us and fulfilling the eligibility conditions may apply as per proforma for selection of Ad agencies/vendors as empanelled under East zone jurisdiction.

The application proforma as per Annexure-1 along with the required documents as enclosures are to be submitted in sealed Cover superscripted with specific item at the following address, so as to reach us before 12.06.2025 at 12 Noon.

CONDITIONS FOR EMPANELMENT:

- 1. The vendors must be of at least 5 years standing.
- 2. The vendors must have annual gross income of Rs.20 lakhs and above for past consecutive three years.
- 3. The vendors should not have any complaint/court cases pending against it.
- 4. The vendor must have a full fledged office in Kolkata.
- 5. The vendor should have reputed firms in its current client list other than LIC.
- 6. The vendor must be GST compliant.

The cover should be superscribed as "APPLICATION FOR EMPANELMENT OF OOH VENDORS AT LIC EASTERN ZONE".

NOTE:

- 1. Vendors who are in the current empanelment list must also apply afresh.
- 2. Vendors who have earlier been blacklisted/removed by any office of the Corporation are barred from applying. Their application will be rejected outright on finding out the same at any point of time, even if they are selected for empanelment by suppressing the fact.
- 3. Authentication Photocopy of the documents are to be submitted mandatorily as supporting documents with application forms. However, originals will have to be shown during on site inspection at a later date, if shortlisted in preliminary scrutiny.
- 4.The decision of the selection Committee in this regard will be final. The shortlisted vendors may be called for personal interaction. The decision of the Committee regarding selection is final and binding on all applicants. No correspondence in this regard will be entertained.
- 5. Submission of application will establish that the applicant has gone through the terms, conditions and procedure, and agreed to abide by the same.
- 6. LIC of India Eastern Zone reserves the right to accept or reject any of or all the applications without assigning any reason.
