GENERAL TERM & CONDITIONS FOR EMPANELMENT

1. The Vendors/Agency/Firm should have their office at Divisional Headquarter - Gorakhpur.
2. The Vendors/Agency/Firm should be in business/profession for at least 3 years.(Copy of Registration certificate must be enclosed)
3. The Vendors/Agency/Firm should have valid registration upto empanelment validity date with State/Local authorities for undertaking the business/profession.
4. The approved Vendors/Agency/Firm should be in position to comply with the urgent need without delay and ready to works at LIC of India, Divisional Office, Tara Mandal Road , Deoria By-Pass Gorakhpur and Branches under Divisional office Jurisdiction .
5. In case of Authorized and approved Vendors/Agency/Firm, Copy of valid authorized dealership certificate must be enclosed.
6. The empanelment would be subject to satisfaction of the Inspection committee, which shall visit the Shop/ Work shop of the Vendors/Agency/Firm to evaluate the capacity of the applicant to execute the assigned job.
7. Vendors/Agency/Firm who have been blacklisted /removed earlier, should not apply. If applied, their applications will not be considered or may be terminated at any time after empanelment without assigning any reason.
8. The Vendors/Agency/Firm should necessarily have GST Registration and also have valid PAN No. issued by Income Tax Department.
9. Applicant has to deposit a non refundable application fee Rs. 500/- + GST @18% in cash at our cash counter of Divisional office, Gorakhpur or in the form of DD favoring LIC OF INDIA, drawn on Gorakhpur
10. Already Empanelled Vendors/Agency/Firm in any category in Gorakhpur Division , a fresh empanelment application for empanelment is required for mentioned category.
11. The Panel shall be valid for 24 month (2 Years) w.e.f. 01.09.2025 .
12. The prescribed application form Annexure-A(Consist of 3 Parts) is to be sent to "Chairman Publicity Committee, LIC of India, Sales Dept. Divisional Office, Tara Mandal Road , Deoria By-Pass Gorakhpur, U.P.-273016".
13. The Application form should be kept in a sealed envelope super scribed as "Application For Empanelment of Vendors/Agency/Firm for publicity related works".
14. Incomplete application will be rejected without assigning any reason, there on.
15. If firms already Empanelled in any other Division of LIC must send certificate of Empanelment along with satisfactory working Certificate .
16. Applications received after the due date and time will not be entertained and therefore deemed to be rejected.

- In case of delay in work , the concerned empanelled Vendors/Agency/Firm should send a communication to the concerned office at least 7 days before the due date for seeking an additional required time to work the same for which approval shall be at the discretion of the competent authority.
- No enhancement in the rate of the work shall be accepted unless previously ratified by the corporation in writing.
- Any tender not in compliance with these terms and conditions will be liable for rejection. If the Vendors/Agency/Firm fails to comply with the provisions of clause regarding work on or before the date mentioned or within such extended time as may be granted by the corporation or in case it fails to comply with the provision of OTHER CLAUSES, they shall pay to the corporation a sum of money equivalent to 0.25% of amount of work order for each day's delay which shall not in any case exceed 1/10th of amount of the gross order. Such sum to be considered and taken as liquidated damages or sum of money forfeited and due from one party to the other for breach of stipulations contained in the said clauses and not as penalty and the corporation shall be at its liberty to deduct such sums of penalty / losses from any moneys due to the Vendors/Agency/Firm or may otherwise recover the same separately.
- It has been mutually agreed between the corporation and the Vendors/Agency/Firm that any dispute arising out of this acceptance shall be referred to for “Arbitration” to the Sr /Divisional Manager (I/C) of the corporation of Gorakhpur Divisional Office and his decision shall be final and binding on the Vendors/Agency/Firm. The Vendors/Agency/Firm shall not raise any question of competence of the Sr/ Divisional Manager (I/C) to act as sole arbitrator.
- The decision of accepting supply of cancelled orders is at the sole discretion of Sr/ Divisional Manager and his decision shall be final in this regard.
