- 3. THE RATES TO BE QUOTED IN ANNEXURE-B SHALL BE ON F.O.R BASIS and INCLUSIVE OF ALL type of TAXES(eg VAT ,Service Tax etc...) and Charges (EG DRIVER EXPENSES, TOLL TAXES, PARKING, DIESEL, PETROL, SOUND SYSTEM, ETC...).
- 4. The VAN MUST BE DECORATED WITH FLEXES OF LIC PLANS AFFIXED ON IRON FRAME ON ALL THE THREE SIDES OF VAN AND PARTIALLY ON THE FRONT SIDE OF VAN.
