## **Points Discussed:**

1) Based on discussions with the representatives of Tour Operators, it was decided that the flights should be made available on **Cathay Pacific Airlines** as these Airlines have flights with suitable timings which will enable passengers to reach and depart as per the RFP conditions.

2 )Based on discussion with the Tour Operators, the Revised itinerary is made and mentioned hereunder:
