

Terms& Conditions:

- 1. Preparation and Submission of Tender: The tender should be submitted in two parts i.e. Technical Bid (Annexure I, II, III) and Financial bid.(Annexure IV- A and IV -B) in separate envelop. The Technical Bid and the Financial Bid should be sealed by the bidder in two separate covers labeled as 1] "Technical Bid for rate contract for Supply, Installation of various types of Water Cooler, Purifier Machine" and 2] "Financial Bid for rate contract for Supply & installation of Water Cooler, water Purifier Machine". Both Sealed Envelopes should be kept in a main/ bigger envelope with tender document with signature on every page and super-scribed as "Tender for Supply, Installation and maintenance of Water Cooler, water purifier wall mount, Water Dispenser and RO/UV water Purifier Machine"
 - 2. .Earnest Money Deposit: The bidder shall be required to deposit the Earnest Money Deposit (EMD) for an amount of Rs. 8,000/-(Rupees Eight Thousand Only) by way of demand draft only. The demand draft shall be drawn in favor of "LIC of India Thane demand draft for earnest money deposit must be kept in the envelope containing the technical bid. The EMD of the successful bidder shall be returned after the successful submission of Security Deposit and for unsuccessful bidder(s) it would be returned after award of the contract. - C) No Interest will be payable by LIC of India on EMD of
- 3. Tender Fee: Tender fee will be Non-refundable amount of Rs. 590/-(Rupees Five hundred and ninety only including GST) by way of or Cash . If paid by DD then the demand draft shall be drawn in favour of LIC of India and receipt of "Tender fees must be kept the envelope containing the technical bid. The bid without receipt of tender fee will be summarily rejected.
- 4. Rate: Rate should be quoted in Indian Rupees (INR) on DOOR Delivery Basis at units located under Thane division

The rates quoted should be indicated in words as well as in figures, as per format specified in Annexure -"IV (A)". In case of any discrepancy, rates quoted in words shall be considered as valid.

- 5. Taxes: Any taxes if payable extra should be clearly mentioned otherwise no taxes/charges will be paid.
- 6. The Bidders may be required to demonstrate the quoted model of the water cooler and purifier during the technical evaluation, if required, failing which their bids/offer shall be rejected. The firms are intimated that they should get ready for demonstration and only one-week time will be provided for arrangement of demonstration and no request for extending time for demonstration will be entertained. Failure to demonstrate, their offer will be summarily rejected.
- 7. Opening of Tender: The Tenderer is at liberty either himself or to authorize not more than one representative to be present at the opening of the tender Technical Bid on 30Th September 2025 at 15:30 pm or on next working day at same time. The representative attending the opening of the tender on behalf of the Tenderer should bring with him a letter of authority from the Tenderer and proof of identification. The late received tenders by LIC of India will be rejected. Further, LIC of India does not accept any liability and responsibility for the tenders in case the same are not properly sealed and marked and/or sent as above.
- 8. Specification: The bidder must confirm in writing that the goods supplied & installed by them shall be as per specification of goods mentioned in Annexure -"I "and in case of any variation, the contract shall be liable to be cancelled immediately. The Security cum Performance Guarantee will also be forfeited.
- 9. Quality of goods: The firm will be entirely responsible for quality of supplied goods/ materials. The supplier should replace the rejected/ damaged goods within 10 days, failing which penalty will be imposed by LIC of India.





- 10. Validity of Contract: The quoted rates must be valid for a period for 365 days (one calendar year) from the date of closing of the tender. And issue of work order. The overall offer for the assignment and bidder(s) quoted price shall remain unchanged during the period of validity of rate contract. If the bidder quoted the validity shorter than the required period, the same will be treated as unresponsive and it will be rejected. In case the tenderer withdraws, modifies or change his offer during the validity period, bid is liable to be rejected and the earnest money deposit shall be forfeited without assigning any reason thereof. The tenderer should also be ready to extend the validity, if required, without changing any terms, conditions etc. of their original tender. After expiry of validity period same rates can be applied for further period on mutual consent and same terms and conditions
- 11. Warranty / Guarantee: The bidder must quote for minimum 01 year comprehensive warranty (Including all Spares, Accessories and Labor) from the date of completion of the satisfactory installation. The bidders are requested to submit their quote (Rates) for subsequent 03 years Comprehensive Annual Maintenance Contract charges (CAMC) (Including All Spares, Accessories and Labour).after expiry of warranty period Failure to comply this condition will entail the rejection of the bids. CMC charges will be taken into account for financial evaluation purpose.
- 12. Authority of person signing document: A person signing the tender form or any documents forming part of the contract on behalf of another shall be deemed to warranty, that he has authority to bind such other and if, on enquiry, it appears that the person so, signing had no authority to do so, LIC of Indiar may without prejudice to other Civil and criminal remedies cancel contract and held the signatory liable for all cost and damages.
- 13. .Delivery& Installation: All the goods ordered shall be delivered& installed within 7 days from the date of issuing purchase order. All the aspects of safe delivery& installation shall be the exclusive responsibility of the supplier. If the supplier fails to deliver& install the goods on or before the stipulated date, then a penalty at the rate of 2% per week of the total order value shall be levied subject to maximum of 10 % of the total order value.
- 14. Right of acceptance: LIC of India Thane reserve the right to accepting the whole or any part or portion of the bid; and the bidder shall provide the same at the rates quoted. LIC of India, Thane divisional office reserve the right to reject any or all tenders /quotations or all offers received in response to the tender or cancel or withdraw the tender notice without assigning any reason thereof and also does not bind itself to accept the lowest quotation or any tender and no claiming this regard shall be entertained
- 15. Performance Security: The successful tenderer will be required to furnish a Performance Security Deposit of 5% of basic cost of the amount will be deducted from the amount of invoice payable to the vendor. After expiry of the rate contract if any of the approved items is required the same will be supplied by the vendor at same approved rates with same terms and conditions if mutually agreed by both parties The security deposit can be forfeited by LIC of India in the event of any breach or negligence or non-observance of any condition of contract or for unsatisfactory performance or non-observance of any condition of the contract
- 16. Arbitration: If any difference arises concerning this agreement, the same shall be settled out by mutual consultation and negotiation. If attempts for conciliation do not

yield any result within a period of 30 days, either of the parties may make a request to the other party for submission of the dispute The Sr. Divisional Manager will be the final authority for it.

- 17. Payment Term: The Tax invoice in triplicate may be send to this office for settlement after satisfactorily delivery, installation and commissioning of the material. The bill should have full particulars of the items. No Payment shall be made in advance nor shall the loan from any financial institutions be recommended on the basis of the order of award of work. The Contractor shall submit the bill only after satisfactorily delivery, installation and commissioning of the material to the satisfaction of the user unit. The case of issuing sanction and passing of bill for payment will be initiated on receipt of installation inspection report. No advance payment or part payment will be made.
- 18. Breach of Terms and Conditions: In case of breach of any terms and conditions as mentioned above, the Competent Authority, will have the right to reject the bid at any stage without assigning any reason thereof and nothing will be payable by LIC of India in that event the EMD shall also stands forfeited.
- The Tenderers should furnish a copy of GST certificate and Pan card of the firm. And Cancelled cheque of the firm. Tenders not complying with this condition will be rejected.
- 20. GST if payable extra should be clearly mentioned otherwise no GST charges will be paid.
- 21. The items will have to be supplied at Thane Divisional office and at various locations at Branches, SOs Located from Thane to Dahanu and Khopoli, Roha, Mahad. No transportation/ cartage charges will be paid.
- 22. Bidder shall submit a copy of the tender document and addendum/corrigendum thereto, if any, with each page of this document should be signed and stamped to confirm the acceptance of the entire terms & conditions as mentioned in the tender document, and submitted in the main envelop.

OTHER CONDITIONS:

- 1. In case of discrepancy between unit price and total prices, The Unit prize shall prevail.
- 2. The cost of Comprehensive Maintenance Contract (CMC) which includes preventive maintenance including testing & calibration as per technical/ service /operational manual, labour and spares, after satisfactory completion of Warranty period may be quoted as per NIT conditions on yearly basis for complete equipment and Turnkey (if any).
- 3. The cost of CAMC may be quoted with GST extra, to be specifically stated. In the absence of any such stipulation the price will be taken inclusive of such taxes and no claim for the same will be entertained later.
- 4. Cost of CAMC will be added for Evaluation purpose. (The L1 will be selected on the basis of total cost of Unit + 5 years CAMC cost (Total of Annexure IV A + IV B)
- 5. The stipulations in Technical Specification will supersede above provisions
