1. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.

2. Years of Past Experience required: The bidder must have experience for number of years as indicated above in bid document (ending month of March prior to the bid opening) of providing similar type of services to any Central / State Govt Organization / PSU. Copies of relevant contracts / orders to be uploaded along with bid in support of having provided services during each of the Financial year.

3. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price. The buyers are advised to refer to the [OM_No.1_4_2021_PPD_dated_18.05.2023](#) for compliance of Concurrent application of Public

Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. 4. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

5. Past Experience of Similar Services: The bidder must have successfully executed/completed similar Services over the last three years i.e. the current financial year and the last three financial years(ending month of March prior to the bid opening): -

1. Three similar completed services costing not less than the amount equal to 40% (forty percent) of the estimated cost; or
2. Two similar completed services costing not less than the amount equal to 50% (fifty percent) of the estimated cost; or
3. One similar completed service costing not less than the amount equal to 80% (eighty percent) of the estimated cost.

6. Reverse Auction would be conducted amongst all the technically qualified bidders except the Highest quoting bidder. The technically qualified Highest Quoting bidder will not be allowed to participate in RA. However, H-1 will also be allowed to participate in RA in following cases:

- i. If number of technically qualified bidders are only 2 or 3.
- ii. If Buyer has chosen to split the bid amongst N sellers, and H1 bid is coming within N.
- iii. In case Primary product of only one OEM is left in contention for participation in RA on elimination of H-1.
- iv. If L-1 is non-MSE and H-1 is eligible MSE and H-1 price is coming within price band of 15% of Non-MSE L-1
- v. If L-1 is non-MII and H-1 is eligible MII and H-1 price is coming within price band of 20% of Non-MII L-1

In Addition to the Service Level Agreement of GeM, Contract shall also be governed by the following terms and conditions.

1) Please note that D.G. Set of reputed make for DG Sets are. **Cummins India / Kirloskar Green /Greaves/Mahindra & Mahindra Ltd./ Ashok Leyland / Eicher Engineers TMTL and TataMotors (Only for 100KVA & 25 KVA not 10 KVA)** only be accepted. DG Set shall be complete in all respects with acoustic enclosure conforming to the norms of pollution control board. The approval of make of Engine, Alternator & Enclosure must be obtained well before procurement. If at any stage it is found that DG set provided is not of approved make, LIC reserves the right to order the contractor to remove the DG set & provide new DG set as per approved makes. Further DG set installed shall be as per **CPCB= 4 + norms only.**

2) Extra Running of DG Set **beyond the package limit of 30/hrs per month will be paid on pro rata basis as per GeM SLA for this service.**

3) Operator Waiting Charges for the duty beyond the duty hours shall be paid as ₹ 100/ hour, further No Extra Operator charges for Saturdays during the duty hours, shall be paid

4) The successful tenderer has to submit copies of invoices after procurement of D.G.Set. The name, address & phone no. of service center shall also be mentioned.

5) The following tests shall be performed at manufacture's outlet prior to packing & dispatch to site :-

a. Load test at full load 50% load, 75% and 110% overload.

b. Fuel consumption at full load, 75% load, 50% load and 25% load.

c. Other routine test as per IS / BS on alternator, exciter and AVR. Original copies of the test certificates shall be submitted to LIC of India.

d. Noise level measurement.

6) The arrangements for providing accessories like new cables, new change-over switches, and fresh earth stations will be made by the contractor at their own cost. If the mentioned items not provided by the vendor, Corporation shall arrange at the risk & cost of the vendor and same shall be recovered from the monthly hiring charges of the vendor.

7) Electric Duty, if any payable to the State Govt. depending on running hours of the DG Set Shall be borne by the contractor. Installation of Energy meter with its calibration and registration with the Statutory Authority shall be done by the contractor at their own cost.

7) The Contract Shall remain in force initially for a period of three years from the date of installation and satisfactory commissioning of the DG Set at Site which may be renewed for further period of two years at the accepted rates / charges and keeping other terms & conditions unchanged, depending upon the satisfactory services rendered by the generator supplier and requirement of the office.

10) Successful Vendor has to obtain Insurance Policies to cover Third Party Liability, Fire and Workmen Co

mpensation Insurance of suitable amount for each policy which shall remain in force till the contract period and extension if granted. Payment shall be withheld if the Insurance Policy Lapse and penalty @ ₹ 200 per day for such lapse period shall be recovered from the bill raised by the contractor.

If the Policies are not renewed within 30 days of expiry, corporation may get the insurance policies renewed and Premium Amounts along with the penalty of ₹ 10000 shall be recovered from the vendor.

The contractor shall be wholly responsible for any mishap during such lapse period and damage recoveries if any shall be made from the payment to the contractor.

11) In the event of breakdown of DG Set due to unavailability of fuel or whatsoever reason on the part of vendor a penalty of 5% of monthly rent per hour shall be levied on the contractor. This penal clause overrides the penalty clause mentioned in GEM SLA.

12) Unauthorized supply of power to other agencies / firms from the DG Set installed at our premises if any are found, action will be taken against the vendor as deemed fit by the competent authority.

13) The Contract is subject to termination at any time if the services are not found satisfactory by LIC or for any other reason whatsoever by serving 30 days' notice in writing by LIC and 90 days notice by the agency.

14) The contractor will have to remove the DG Set from the LIC Premises within 07 (Seven) days from the date of termination or closure of the contract at their cost, else demurrage charges @ ₹ 1000/day will be levied by the LIC of India, on the contractor.

15) A Log Book shall be maintained for recording daily running of DG Set which should be signed by the DG Set operator and verified by the authorized official of LIC of India.

16) LIC of India shall not be responsible for any injury partial or permanent or death of any worker at site due to accident or by personal negligence of the staff of the contractor. LIC of India will remain indemnified by the contractor on this account.

17) Contractor shall be responsible for payment of wages / salaries and allowances to his personnel that might become applicable under any government order. LIC of India shall have no liability whatsoever in any manner.

18) In terms of provisions of Section 33 (3) of the Insurance Act, 1938 as amended by the Insurance Laws (Amendments) ordinance, 2014. Insurance Regulatory Authority of India (IRDAI) is authorized to verify all such books of account, register, other documents and data base in the custody of the contractor in respect of service outsourced by the LIC of India.
