#### SCHEME FOR SALE OF 1No. OF VACANT LAND UNDER MSTC e-AUCTION PROCESS

Terms & Conditions of the Scheme for the sale of above:

1. LIC OF INDIA intends to sell vacant land (sketch enclosed)to the extent of 6835.14 sq.ft. situated in Block 34, Ward B, ChandrasekarapuramFirst Main Road, Ambattur, Chennai-600 053 in (Survey No:661/1AI (part), 662/1A1 (part), TS No:14) through e-auction to the General Public /Organization/Body at the sole discretion of LIC OF INDIA, SZO, CHENNAI.

# 2. LOCATION:

The said land is located at Chandrasekarapuram First Main Road, Ambattur, Chennai 600 053, which is about 1.5 km from Ambattur OT Bus Terminus and about 1 km from Ambattur Railway Station. The exact location is shown in Annexure – I.

# 3. DETAILS OF PLOT:

- (I) One vacant land covered by fencing on all sides is available under Public e-auction to the General Public/Organization / Body— <u>Details available in</u> Annexure A
- (II) The land will be sold on "As is where is", "As is what is", "Whatever there is and without recourse basis" under E-Auction through MSTC Ltd.

#### 4. SALE PRICE OF PLOT:

The sale price of the plot is excluding stamp duty and registration charges as per the prevailing government rates, and other statutory charges if any, and GST as applicable.

#### 5. ELIGIBILITY:

- 1) Any Individual who is an Indian National and has attained the age of 18 years at the time of applying and competent to contract is eligible to bid.
- 2) A Company, a registered Firm, a LLP is also eligible to bid.
- 3) The Plot will be put to sale through MSTC Ltd public e-auction for the highest bidding.





#### 6. CONDITIONS:

Earnest Money Deposit (EMD) of Rs.6,00,000/-(Rupees Six Lakhs Only) is to be paid. It shall be adjusted towards the cost of the plot payable by the highest bidder. In case the successful allottee fails to comply with the terms of allotment or otherwise within the stipulated time, not only the allotment will be cancelled, but the full amount of EMD will be forfeited.

## 7. HOWTOAPPLY:

The eligible/interested persons can apply/participate for the subject sale in the MSTC e-auction portal.

#### 8. REGISTRATION OF DOCUMENTS:

Once allotment is made, the allottee shall enter into an agreement with LICof India for appropriate stamp value as applicable in the Stateof Tamil Nadu.

The Sale deed shall be as per the draft of LIC of India and the draft shall be made available by LIC of India for perusal on request before the time of registration.

The allottee shall bear stamp duty and the registration chargesforthe sale deed as per the Prevailing government rates, and other statutory charges, *viz*. GST etc.The possession of the plot shall be handed over only after the entire sale consideration and the other statutory charges are paid to LIC of India

# 9. MODE OF PAYMENT AFTER ALLOTMENT AND REGISTRATION OF DOCUMENTS:

The allottees shall deposit the sale price as per the stages mentioned below:
