An Indian-Owned Company shall mean a company incorporated in India in which more than 50% of the beneficial equity ownership is held, directly or indirectly, by one or more of the following:  (a) Indian citizens; (b) Indian companies (as defined under the Companies Act); (c) Persons of Indian Origin (PIO) / Overseas Citizens of India (OCI); (d) Individuals who are resident and ordinarily resident in India under the Income-tax Act, 1961.  2. An Indian-Controlled Company shall mean a company incorporated in India in which management and controlling interest is exercised, directly or indirectly, by one or more of the persons/entities specified in clauses Sl. No. 1 (a) to (d) above, with effective control over strategic, financial, and operational decision-making, whether through shareholding, voting arrangements, board representation, or contractual rights.
