Kindly Note:

1) This bid is floated for procurement of First Premium Receipts used by Life Insurance Corporation of India, with size of **15" x 8" x 1 with perforation at center, sample uploaded in the bid i.e. in each sheet 02 (Two) receipts will be printed.** These Renewal Premium Receipts are computer continuous stationery printed on paper of having thickness of paper as minimum 70 GSM with single color both side printing.

2) For Double Side Printing each side is counted as single page and rates are called for 60000 sheets, as such 30000 sheets will be both side printed, same is incorporated in the bid preparation and vendors are advised

sed to quote rate accordingly.
