SCOPE OF WORK UNDER CAMC

1. Inspection of indoor & outdoor units of Air conditioners & / or the system & carrying out preventive maintenance on quarterly basis.
2. Checking the refrigeration system, motor & starters etc. for performance & ensuring the overall healthy condition of the AC system.
3. Checking the system for leaks & then rectifying the leaks, if any.
4. Taking a set of readings of the system to evaluate satisfactory performance of AC system.
5. Cleaning the evaporator and condenser coil four times a year.
6. Chemical cleaning of evaporating coils if required.
7. Lubricating the fan motors as and when required.
8. Inspection of V-belts, making necessary adjustments and / or replacement of worn out belts if necessary.
9. Repairing/ replacing the components of the equipment at site or at the service station as and when required.
10. Overhauling of components of the equipments whenever necessary.
11. Replenishing and topping up the refrigerant gas as a result of a leak from the system including arresting the leak.
12. Repair / Replacement of microprocessor control.
13. Attending to the complaints / breakdown calls whenever received.
14. Replacement of defective equipments such as **Compressor**, Fans, Control / Microprocessor panel including internal cables/wiring & all types of piping including replacement of all types of filters but except sheet metal & plastic parts, grills , MCBs etc.
15. Cleaning of drain piping external to the machine.
16. The servicing is to be carried out by experienced technicians. The technician should submit the report to LIC mentioning repairs carried out, healthiness of the system & suggestions for improvement if required.
17. Payment towards service charges will be released on quarterly basis after rendering services as per tender conditions & on submission of bill in Triplicate along with the service challans duly signed & sealed by LIC representative. The Annual Comprehensive maintenance rates mentioned in the Bill of Quantities are inclusive of all taxes & hence payment will be released after making necessary deductions at source as per Rules.
