Amendments to the RFP

1. Section 4.23 - Sub-section B –Performance Bank Guarantee(PBG):

Existing clause:

The PBG should be of a Nationalized/Scheduled Bank only and should be valid for the period of 54 months from date of submission (including additional six months period) .

Revised clause:

The PBG should be of a Nationalized/Scheduled Bank only and should be valid for the period of 51 months from date of submission (including additional three months period) .

2. Section 4.12 - Sub-section a) Eligibility bid Point no: 10:

Existing clause:

Minimum one reference customer in India where Oracle Licenses has been provided (as per Annexure XII) along with attested copies of Purchase orders.

Revised clause:

Minimum one reference customer in India where Oracle Backup appliance has been provided (as per Annexure XII) along with attested copies of Purchase orders.
