3.	MINIMUM ELIGIBILITY OF IBS AGENCY	:	<ul style="list-style-type: none"> • The agency must have IP-1 License issued by Department of Telecommunication (DoT). • The working agency in GIFT CITY/AHMEDABAD/GANDHINAGAR. • Documentary evidence is required to submit along with offer.
4.	VALIDITY OF OFFER	:	The Quotation shall be valid for consideration for a period of 60 days from the date of opening of Quotation.
5. 8.	COMPLETION TIME	:	Initially the infrastructure work to be completed within 60 Days for 18 th , 17 th , 16 th & 15 th Floors. Then as and when the floors are getting occupied, the IBS Infrastructure works to be completed in line of usages of the floor and interior works.
9.	TENURE	:	Right to operate shall be given to successful agency for 09 Years . The same can be renewed mutually for further 03 Years. However, if the successful agency failed to provide minimum one telecom operator in the building after occupation of 02 Floors, LIC reserve the right to terminate the contract and/ or allow other IBS provider/telecom operator with 30 Days Notice. No compensation in this regard shall be payable by LIC.
10.	AREA PROVIDED BY LIC	:	Maximum 300 Sq Ft at Terrace/Basement of the building.
11.	ELECTRICITY	:	15 KW Electrical power point with sub-meter shall be made available by LIC of India. The Electricity consumption Charges shall borne by IBS Operator. However, If GIFT Power Ltd. insist for separate power connection, then the same shall be responsibility of IBS agency to obtain separate electrical connection in their name.
12.	Access to the Property	:	24*7 days access to the tower area shall be facilitated to IBS agency, its customers (i.e., telecom operator), or their representatives.
13.	Property Taxes/Fess	:	Any property tax/fess levied due to installation of IBS shall be borne by IBS agency.
14.	STATUTORY GUIDELINE	:	It is the responsibility of IBS agency to follow all GIFTCL/Statutory Guideline prevailing during the Contract.
