- **1. <u>Submission of BID:</u>** The Service Providers fulfilling the ELIGIBILITY CONDITIONS and agreeable to the Terms and Conditions are to apply as per:

- (f) All above documents are to be put in a sealed envelope super-scribed as **Tender for** making and providing Identity card FY 2023-24"

- 2.3 The tender should be sent so as to reach this office **ON OR BEFORE THE DATE AND TIME SPECIFIED.** Tenders received after last date and time specified time will be rejected.
- 2.4 The Service Providers are requested to note that, non-compliance of the above instructions is liable to their being considered non-bonafide.

3. NON EXCLUSIVE AGREEMENT:
