- 44. LICI shall not be responsible for any injury partial or permanent or death of any worker at site due to accident or any other reasons or by personal negligence of the staff of the contractor. LIC of India, will remain indemnified by the contractor on this account.
- 45. The firm shall be fully responsible for any liability / compensation in case of any accident or otherwise any untoward incident at his own risk for the staff deputed by the firm and LICI shall not give any compensation.
- 46. First Aid box shall be arranged by the contractor at site of work at their cost.

- 53. In case of dispute, the matter shall be settled mutually, failing which the decision of the Sr. Divisional Manager(I/C), LIC of India, Jaipur, shall be final and binding on the bidders.
