Security Deposit can be either in (1) Cash or (2) in the form of Bank Guarantee. (1) In case of Cash option, the Security Deposit shall be recovered from R.A. Bills at 7.5% of Gross amount of bill till the sum along with sum already deposited as EMD equals the total security deposit. If the total amount of EMD is submitted in the form of Bank

8.	The time given for submission of tender is insufficient to work out the rate	Tender Program has been revised as above.
9.	What finishes and works are under scope of this contract	Except internal floor tiling & internal painting of the office area, all works as detailed in 'Scope of Work' and 'Design Basis Reports' of all trades.
10.	For eligibility Criteria regarding Work Experience, enhancement of amount of 7% p.a. is mentioned in tender, whereas Odisha Govt. is allowing 10%	As per our Internal department circular, we are allowing 7% enhancement.
11.	SI No. 20 of Form for Qualification of Bidders – P1 requires Bidding Capacity whereas formula for calculation of Bidding Capacity not mentioned	This may be ignored as we have removed the Bidding Capacity criteria from Minimum Eligibility Criteria.
