The car will be available for inspection at the LIC Officers’ Flats, Ranjit Avenue, E-Block, Amritsar between 2.30 pm to 4.30 p.m. during working days from 14.10.2016 to 28.10.2016 (except Saturday, Sunday & holidays). 4. **OPENING OF TENDERS & VALIDITY PERIOD:** The tenders received up to **5.00 PM on 31.10.2016** will be opened at **11.00 AM on 01.11.2016** in the Chamber of Manager(IT) Divisional Office, Ranjit Avenue, Amritsar-143001. The tenderer may remain present at the time of opening of tender if they so desire. The highest bidder will be informed about his bid being successful after approval by the Competent Authority. The successful bidder will have to pay the balance amount of the bid (after adjustment of EMD) through Demand Draft within seven days from the date of receipt of offer. The Demand draft should be drawn in favour of LIC of India, payable at Amritsar. The handing over of car will be subject to the realization of Demand Draft but not earlier than seven days.

5. Failure on the part of the successful tenderer to comply with the foregoing procedures will result in the forfeiture of the EMD amount remitted along with the tender.

6. The EMD amount will be refunded to the unsuccessful tenderers without any interest thereon on realization of the Demand Draft only, within one month from the date of finalization of tender.
7. The tenderer has to sign on all the papers of tender being submitted.

The Successful bidder in the auction will be required to give an undertaking on STAMP PAPERS of appropriate value duly Notarized that the vehicle will not be used for driving purpose and will be used as SCRAP by dismantling into parts. The Corporation will not be responsible for anything like Charges, Taxes, Legal disputes etc. if any in respect of the Car after its sale.
