- 1. For arriving at current cost of similar works, value of qualifying work executed (by the bidders in the last 7 years) shall be brought to current costing level by enhancing the actual value of work at simple rate of 7% per annum calculated from the date of completion to the date of bid II (Qualification bid) opening.
- 2. 'Similar nature' means the characteristics of the completed works should be similar to that of proposed work in terms of physical parameters, like finishes, complexity, method/ technology and / or other characteristics described and scope of works.
- 3. Generally, similar nature of works means modernisation/ interior works of Office, Shopping Complex, Commercial building and Institutional building. Whenever composite tenders are invited the definition of similar nature of work shall include the major Trades of work proposed to be included in the composite tender.

Key Construction Activities Criteria: Applicants/Bidder should have completed 50% in number of any of following key construction activities as included in the scope of the proposed work, either completely separately or combined in qualified works (contractor Completed): If the Proposed works has the following 10 numbers key construction activities, then the applicants/bidders should have carried out at least 5 out of them,

i) Double Skin Internal Partition work of Metal/wooden frame works ii) Wall

Cladding / Lamination works iii) False Ceiling Works iv) Air Conditioning

v) Fire Alarm Work vi) Network and Telephone Cabling vii) Internal Electrical Installation with Fixtures, viii)Plumbing works, ix) . Brick work and x) Tile flooring.

Attach the Performance Certificate showing the Key activities or submit the final bill copy certified by the employer.

- 4. The applicants/ bidders need to submit completion certificate for all qualifying works, containing the details such as date of commencement & completion, details of similar nature of works, final completion cost duly certified by the authorised officials in case of Govt/ Semi Govt. Or public sector under taking.
- 5. In case, qualifying works are from Private sector, the applicants/ bidders to submit payment received details duly certified by the Chartered Accountant. If called for documents such as copy of final bill, Form 26AS and Form 16A or other relevant documents, to be submitted for verification.
- 6. Even if an applicant meets qualification criteria, he shall be subject to disqualification if he or any one of the constituent partner/ Director is found to have:
 - i) Made misleading or false representation in the forms, statements, affidavits and attachments submitted in proof of the qualification requirements and / or
 - ii) Records of poor performance during the last five years, as on the date of NIT, such as abandoning the work, rescission of the contract for reason which are attributable to non performance of the contractor, in ordinate delay in completion, consistent history of litigation resulting in awards against the contractor or any of the constituents, or financial failure due to bankruptcy and so on and / or



- 7. The bidder as a Joint Venture is not eligible for participation in Bidding.
- 8. Performance Report for qualifying works shall be called from Client as per Proforma Annexure 'A'.

Only contractors who have carried out similar nature of interiors works of offices, residential buildings, shopping complex, commercial buildings and fulfilling above criteria shall alone participate in the e-tendering process.

<u>The Tender Documents Consist of - BID -I, BID -II & BID III</u>. The tenderer shall quote their offer in relevant page in Part III of BID III. Contractor has to submit the Tender as under:

- (1) <u>BID I (EMD BID)</u>: Big Sealed envelope consisting of two separate sealed envelopes as per the following shall be <u>submitted in physical form as BID I</u>:
 - (a) Tender Fee (non-refundable) of Rs. 590/- (inclusive of GST) in the form of Demand Draft/Pay order in favour of "Life Insurance Corporation of India" payable at Ernakulam or Cash remitted receipt from DO Ernakulam Cash Counter.
 (b) Earnest Money Deposit of Rs.1,34,000 /- (Rupees One Lakh Thirty Four Thousand Only) in the form of Demand Draft/Pay Order/Banker's Cheque in favour of "Life Insurance Corporation of India" payable at Ernakulam
- (2) <u>BID II</u>: <u>Prequalifying Bid</u> (Enrolment form with Annexures) (Page No. 1 to 35). The Tenderer shall fill, signed & stamp in the enrolment form and upload the supporting documents / attachments.
