1. For arriving at current cost of similar works, value of qualifying work executed shall be brought to current costing level by enhancing the actual value of work at a simple rate of 7% per annum calculated from the date of completion of the work to the date of BID-II (Qualification Bid) Opening.
2. **"Generally Similar Nature"** means the characteristics of the completed works should be similar to that of the proposed building in terms of physical parameters, like **High Rise Building for external structural repair & painting**, method/technology and/or other characteristics described and scope of works.

Major Structural Repair works and shall have proper proof for executing such works which may involve major structural components works in the building and shall **have executed atleast three works of value Rs.100.21 Lac or two works of value Rs.125.26 Lac or one work of value Rs. 200.41 Lac towards works specified.**

They shall fulfill atleast **any two** of following Key Construction Activities at Sl. No. 1, 2, 3 and 4 as included in the scope of the proposed work, either completed separately or combined in qualifying works (contract completed):

- (c) In case applicant/bidder is qualifying under criteria of work experience with One completed works of similar nature (contract completed) costing not less than the amount equal to 80% of the estimated cost, then 50% in numbers of any Key Construction Activities of proposed work shall be completed in this qualifying work or in any of the other completed works of similar nature (contract completed) having value equal to or more than 40% of the estimated cost

Note: For Evaluation: Qualification Criteria for Key Construction Activities: At least 50% activities as mentioned above to be available. Minimum qualifying amount for individual activities need not be specified.

iii) AVERAGE ANNUAL FINANCIALTURN OVER:

- ii) Records of poor performance during last five years, as on the date of NIT, such as abandoning the work, rescission of the contract for reason which are attributable to non performance of the contractor, inordinate delays in completion, consistent history of litigation resulting in awards against the contractor or any of the constituents, of financial failure due to bankruptcy and so on.

vi) **JOINT VENTURE:** Joint Ventures applicants will not be considered.
