- 2) Quoted rates shall be valid for a period of 1 year, with a provision of 25 % increase or decrease in the te ndered quantity.

- 4) After award of contract, successful bidder shall submit the soft copy for Proof reading within 7 Days afte r the art work provided to the bidder and delivery period of one month shall start once proof is approved b y the office.
- 5) Successful bidder is required to make entire supply ordered by LIC of India Srinagar Division within stipu lated time of one month or as mentioned in the order and in case the firm fails to supply the goods/items w ithin the time limit/or not as per the required specifications penalty @ as given below will be calculated an d deducted from the invoice without any intimation.

- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

This Bid is governed by the <u>General Terms and Conditions/सामान्य</u> नियम और शर्तें, conditions stipulated in Bid and <u>Service Level Agreement</u> specific to this Service as provided in the Marketplace.
