Following are the points discussed /queries raised by the Tour Operators and Clarifications / Modifications thereon;

Hubs – As per Financial Bids , Hubs for France Tour are as under.
 Ex-Mumbai (10), EX-Delhi(40), Ex-Kolkata(31) & Ex-Hyderabad(9)

Tour Operator suggested addition of more Hubs in addition to the above mentioned Four Hubs.

#### Clarification/Modification:-

It is clarified that there is no modification in the Hub Criteria.

2) <u>Meals</u> - In the Financial Bids of France Tour, we have mentioned Breakfast, Lunch, High Tea & Dinner on the Day-4. Tour Operator suggested removal of High Tea & Dinner on the 4th day as the Group will take return flights in the evening.

# Clarification/Modification:-

Tour operators will have to provide Dinner in Flight or at land as per the timings of the departure of flights.

**3)** <u>France itinerary-</u> Tour operators have suggested to replace "Montmartre Funicular Ride" with "Disney Land".

### Clarification / Modification:-

It is clarified that "Montmartre Funicular Ride" is replaced by "Disney land"

Accordingly revised itinerary is as follows.

Seine River Cruise, Versailles, Fragonard, Ornate State Apartments, Photo Stop at Louvre Museum, Paris City Tour, Eiffel Tower, Montparnasse, Disney land, shopping time at Champs Elysees.

4) <u>Conference at France - In the Tender, we have mentioned in "PART A- NOTICE INVITING TENDER"</u> that arrangement has to be made for half day conference preferably on Day -1, for which conference hall and necessary logistics will have to be arranged. Tour operators have suggested that Conference can be conducted on the 2nd day of the Tour i.e in the evening from 6.00 pm to 9.00 pm

Clarification / Modification:-

It is clarified that there is no modification in the said clause.

5) Shortest Distance through Air: It is mentioned in the Financial Bid about the provision of Non stop / one stop /shortest connecting flights (for departure as well as arrival). It was suggested by us to conduct the sightseeing Tours through shortest route.

Clarification / Modification:-

Planning of sightseeing /local tour should be made in such a way that all the itinerary places can be covered in relaxed manner. Flight booking be managed in such a manner that arrival at the destination should preferably be in the forenoon and departure from the destination should be in night so that maximum time may be utilized on both arrival date & departure date.
