- 1. At the outset, Mr. K R Ashok, Executive Director (Actl/Admn/IT Implementation/ ACGC) made a briefing about the purpose of the pre-bid meeting.
- 2. In response to the queries received through e-mail, it was told that a consolidated response to all the queries will be published on the website of LIC of India and also on website https://www.tenderwizard.com/LIC
- 3. Prospective bidders were given further opportunity to put up their queries through e-mail to designated email id by the end of the day i.e. 10.01.2024. - 4. Following questions were asked in the meeting:
 - When prospective bidders can expect the response on queries raised by them. It was told that it will be published possibly tomorrow or day after tomorrow.
 - II. Whether there is any scoring system for evaluation of Technical bid. It was replied that whoever meets the minimum criteria mentioned in RFP will pass through technical evaluation phase.
 - III. Whether there is any limitations on number of bidders participating in Online reverse Auction. It was replied that there is no such limitation about number of bidders participating in online reverse auction and we have not kept any limitation on number of Bidders passing through the Technical evaluation phase.
 - IV. Question was asked regarding timeline to end the work. It was replied that the timeline is already mentioned in RFP.
