- 1. For arriving at current cost of works, value of qualifying work executed (by the bidders in the last 7 years) shall be brought to current costing level by enhancing the actual value of work at simple rate of 7% per annum calculated from the date of completion to the date of submission. Attach the Performance Certificate showing the Key activities or submit the final bill copy certified by the employer.
- 2. The applicants/ bidders need to submit completion certificate for all qualifying works, containing the details such as date of commencement & completion, details of civil nature of works, final completion cost duly certified by the authorised officials in case of Govt/ Semi Govt. Or public sector under taking.
- 3. In case, qualifying works are from Private sector, the applicants/ bidders to submit payment received details duly certified by the Chartered Accountant. If called for documents such as copy of final bill, Form 26AS and Form 16A or other relevant documents, to be submitted for verification.
- 4. Generally, civil nature of works means construction of Office, Shopping Complex, Commercial building and Institutional building, structural repair works, modernisation/interior works, civil repair works and painting works.

5. Key Construction Activities Criteria:

Applicants should have completed at least 2 out of any of following key construction Civil activities, either completely separately or combined in qualified works (contractor Completed):

- a) Construction of building
- b) Painting works
- c) Civil Repair and maintenance works
- d) Modernisation/interior works
- e) Structural repair works
- 6. Even if an applicant meets qualification criteria, he shall be subject to disqualification if he or any one of the constituent partner/ Director is found to have:
 - Made misleading or false representation in the forms, statements, affidavits and attachments submitted in proof of the qualification requirements and / or
 - ii) Records of poor performance during the last five years, as on the date of NIT, such as abandoning the work, rescission of the contract for reason which are attributable to non performance of the contractor, in ordinate delay in completion, consistent history of litigation resulting in awards against the contractor or any of the constituents, or financial failure due to bankruptcy and so on and / or
- 7. The applicant as a Joint Venture is not eligible for participation in empanelment.
- 8. Performance Report for qualifying works shall be called from Client.
